

As **Mr. Samih Mahmoud Al-Alawi** resigned his post on the Board of Directors in July 2013; the First Reserve Member **Ms. Huda Sultan Faraj** joined the Board of Directors as of July 2013.

During its term which ends this day, the Board of Directors held 12 ordinary meetings and four extraordinary meetings, during which the Board prepared, planned for and followed up on the implementation of BSE's various programs and activities.

At the beginning of the round, the Board set up a plan that goes hand in hand with the strategic plan and took into consideration the plans and programs adopted by the previous management as well as the recommendations of the General Assembly, regarding the utilization of available resources. This is in addition to offering programs and activities designed to attract the members to participate and take advantage of an array of events and functions. The plan also provides activities that are intended to boost BSE's relationship with official agencies, professional, social and scientific societies both inside and outside Bahrain, Arab and International engineering associations and institutions, particularly the Federation of Arab Engineers and the Gulf Engineering Union.

Although the global economic meltdown continued to cast shadow during the past year and covered all aspects of life, BSE managed to resolve the difficulties and to properly accomplish all its programs in line with the established plan.

We, BSE's Board of Directors, see it as our obligation to draw attention to the fact that all of the achievements made by BSE were made possible by many preparatory meetings, correspondence and communications. The burdens were shouldered by a small number of members dedicated to volunteer work. They donated all their



resources and most of their time, not withstanding their handful of worries and busy schedule, to process and highlight the activities of BSE in an honorable fashion as in the detailed report in your hands.

For this reason, we have to remind you that we are in dire need for you to contribute part of your precious time through participation in the functions of the permanent and temporary committees and join forces with your colleague engineers who worked effectively to implement these activities with great success.

During the past year and the beginning of this year, many activities and events were implemented on the basis of the work plan. We summarize below the most salient of these functions:

- A historical celebration was organized under the patronage of His Majesty the King of the Kingdom of Bahrain on 8 May 2013 at the Gulf International Convention Center at Gulf Hotel, marking the 40th anniversary of BSE. His Majesty was represented by His Excellency Shaikh Khalid bin Abdulla Al-Khalifa, Vice President of the Council of Ministers. The event celebrated and honored the previous chairmen and the ministries and companies who supported BSE. A documentary book narrating the history of BSE since its establishment was distributed and documentary films were produced on this occasion.
- Members of the Board of Directors and members of the organizing committee of the celebrations marking the fortieth anniversary of the establishment of BSE were honored by the visit of His Majesty the King of the Kingdom of Bahrain His Highness the Crown Prince expressed their thanks and appreciation in support of BSE ever since its inception 42 years ago., Sincere thanks was also conveyed to His Royal Highness the Prime Minister for his continuous support towards BSE.
- 3 BSE Board held a series of meetings with the senior officials in the kingdom including ministers in an endeavor to enhance relation and discuss mutual topics of interests.
- 4 BSE continued effectively to appoint its representatives in specialized committees in accordance with the ministries' requests.
- In order to provide adequate parking space for the vehicles of members while in BSE Headquarters, the Board of Directors utilized the expansive lot of land in the yard to provide more than fifty parking spaces. However, efforts are continuing with the Royal Court to include the land adjacent to BSE premises to our property.
- The Board of Directors managed to complete a large part of the arborization of the yard of BSE by planting palm trees and is now in the process of completing the project during the year 2014.
- The Board of Directors implemented "Majlis Almohandiseen" project. It is our hope that BSE members will be present on an extensive and a regular basis in a way that would create an ambiance of camaraderie, promote acquaintances with each other and strengthen the relationships and rapport among the members.
- 8 BSE organized four conferences and exhibitions during the past year in collaboration with some local, Arab and International major industrial institutions, institutes and societies.
- 9 The number of training courses and workshops organized by BSE solely or in cooperation with other agencies reached 13.

- 10 BSE issued two editions of the "Al Mohandis" magazine during the year 2013.
- BSE also regularly issued eleven editions of the "Al-Mohandis Times" publications, containing a monthly inventory of all activities and events organized by BSE.
- BSE organized a number of events during the past year, including eight specialized lectures and seminars as part of Tuesday Forum.
- 13 The total number of members admitted during the year 2013 reached 125 members.
- The Board of Directors made the necessary arrangements to develop the Services Section, south of BSE premises to provide a better place for BSE's watchman and ,move the air-conditioners to a more appropriate location.
- BSE signed a memorandum of understanding with Kerala Engineers (KEEN4) for the sake of regulating and enhancing their activities in collaboration with BSE. MOUs with other engineering entities were also updated.

The Board of Directors has made several and multi-faceted achievements and yet they remain below our ambitions. We are fully aware that the scope is still open avoid deficiencies, overcome the negative aspects and realize more developments through implementation of more projects which are still ideas on the drawing board under consideration.

Based on the above premises, we list below some of the recommendations and proposals of the new Board of Directors:

- 1. Ensure that efforts are continued with the concerned authorities to change the engineering cadres in both public and private sectors.
- 2. Continue communications with the Royal Court in connection with the plot of land located south of BSE premises to become part of BSE's property.
- 3. Ensure that there is a law by virtue of which all engineers in Bahrain are registered under the umbrella of BSE.
- 4. Organize training courses that grant academic certificates approved by higher training authorities.
- 5. Organize professional courses for "Chartered Engineer" certificate.
- 6. Strengthen the relationship with all ministries in the Kingdom of Bahrain in favor of engineering sector and BSE members in particular.
- 7. The Board of Directors recommends to approve the appointment of Talal Abu Ghazaleh Organization to serve as external auditor for the new term of the year 2014.

Second: External Relations

Fourth: Engineering Courses & Management Training



Introduction

Bahrain Society of Engineers – Training Centre (BSETC) conducted 13 workshops during 2013 as detailed in the attached table. The courses were selected according to the received requests from engineers, employers and requirements of the market to improve the knowledge and skills of the engineers and engineering profession. There were free seats offered to BSE members in the conducted courses and four BSE members have benefited from this option.

BSETC has been getting a rating of "Inadequate" from the "National Authority for Qualifications and Quality Assurance of Education and Training" (NAQQAET) in their Audit Reports during previous years. As directed by Bahrain Society of Engineers' Board of Directors, BSETC exerted continuous efforts on implementing NAQQAET Audit Findings of 2012 Audit Report to improve BSETC rating with NAQQAET. Accordingly, the following objectives have been achieved:

- 1. Strengthen BSETC's manpower by employing a Training Manager and Assistant Training Officer as per the request of the NAQQAET.
- 2. Engagement of a consultancy firm specializing in Quality Assurance of Education and Training to assist BSETC in improving BSETC rating. Tamkeen Support has been obtained which covered 80% of the consultancy fees for this project.
- 3. The BSETC Quality Management System has been drastically improved and various Standard Operating Procedures (SOPs) and new forms have been introduced which were implemented on all conducted courses
- 4. To continue improving BSETC, the training centre issued a strategic plan till 2016 and an action plan with Key Performance Indicators (KPIs) for the year 2014.
- 5. An application was submitted to obtain Tamkeen Support to purchase interactive electronic board, photocopier, and personal computers to improve the classroom training resources.

2014 Plans and Suggestions:

For year 2014, it is recommended to achieve the following:

- 1. Setting the strategic plan till 2016 and meeting action plan for 2014.
- 2. Continuation of satisfactory qualification level of National Authority of Qualification and Quality Assurance for Education and Training (NAQQAET). To improve during 2014 to at least achieve a rating of "Good" level.
- 3. Liaison with Government Ministries to promote and offer new certified professional courses.





Fifth: General Activities



1. Social Activities:

- a. The Committee organized on Friday 19 April 2013 barbecue night in the open air at the back external yard of BSE premises. This event was attended by a number of the BSE members.
- b. During the holy month of Ramadan, BSE organized two recreational nights (Ghabgah) on Tuesdays 16 and 30 of July 2013. This event received an overwhelming response by BSE members and nearly 400 attended.
- c. On 14 January 2014 the "Diwaneyat Almohandiseen" was launched at BSE premises with a barbecue night in the open air which was attended by 130 members. The Board of Directors announced that it will send invitations to the members to attend the Diwaneyah on the first Tuesday of each month for the sake of promoting and enhancing relations among members. There will be soft recreational games waiting for you.

2. Technical Visits:

On Saturday morning, 5th October 2013, the Committee organized a field visit to the Muharraq Station Project and the deep lines to familiarize themselves with the related details. Around 40 BSE members took part in this visit.

Academic Scholarship Program

University of Bahrain Grants:

BSE continued to give financial grants to a number of engineering students at the University of Bahrain. In this respect, 40 students applied for the scholarship and 26 students benefited from the same this year, while 4 withdrawn to study non-engineering disciplines or transferred to universities other than the University of Bahrain. This year 4 grant students graduated from various engineering disciplines. 8 applicants were approved to join the program. So far the total number of students who benefit from this program is 22 students.

Conferences & Training Courses

BSE offered the opportunity to a total of 85 BSE members from various membership categories to attend conferences, courses and workshops free of charge. 81 of them attended conferences conducted by BSE while 4 members attended training courses and workshops. Furthermore, a number of members were also sponsored to attend conferences organized by public and private sectors during the same year.

Activities and Events

► Female Engineers Committee

The Female Engineers Committee took part in all the periodical meetings that were organized by the High Council for Woman through our representative Huda Sultan Faraj. This included attendance of female engineers to some awareness symposia related to women and her affairs.

Career Exhibitions

In line with its interest in raising awareness of students to attract them to study engineering professions, BSE took part in the following career exhibitions:

Career Expo 2013 organized by the University of Bahrain during the period 14-16 March 2013. Throughout the three exhibition days, BSE members consecutively was present at the BSE stand.

BSE received an invitation from Al-Ahlia Education & Training Support Association to take part in the Career Expo that was held at the Bahrain International Exhibition Center during the period 29-31 October 2013.

An introduction seminar about BSE was conducted at the Seminars Room for Shaikh A. Aziz School on 10th December 2013 to familiarize the students with the history and the services and facilities provided by BSE in various fields of engineering and training.

A field visit was made on 20 June 2013 to the Gulf Petrochemical Industries to introduce BSE members to the petrochemical products and how the theoretical aspects of chemical and mechanical engineering studies are applied in the company's system.

As requested by the University of Bahrain, the students of the mechanical section were introduced to BSE activities and membership privileges. The engineering students were also familiarized with the important role played by BSE.

BSE received an invitation to visit the Bahrain Polytechnic University to make a presentation on the programs offered at BSE. A delegation from the Membership and Profession Affairs Committee held a meeting on 23rd January 2014 with Dr. Hasan Al-Mulla, Vice Chief Executive Officer, Dr. Khalid Essa, Chief of the Engineering College and a number of members from the administrative and academic Board.

Seventh: Information Affairs



Introduction:

Information committee has targeted to enhance and promote BSE's position into the social and media environment of Bahrain as a well established professional society. The committee has developed and implemented a strategy to reach the desired goal, through the close focus on relations with all Arabic and foreign media using all modern communication channels. Hence, a Media Officer was recruited to enhance and develop BSE role in this aspect. The details of accomplished tasks by the committee is summarized as follows:

1 Press Releases:

During 2013, we issued 37 various press releases covering almost all the activities and events organized by BSE. They were published by almost all the local newspaper as well as Arab and foreign media.

2 Media coverage of the conferences:

Information Committee covered all conferences & exhibition in cooperation with Conferences Director and concerned Media Committee appointed by the Conferences Organizing Committees, especially during the opening ceremonies. The work includes the preparation of media coverage before and after the events, in addition to extending the invitation to the media and distribution of releases to them

Other tasks that the committee conducted included:

- Archiving media coverage.
- Prepare coverage performance monthly reports to measure BSE media performance.
- Perform any tasks related to the issuance of booklets by BSE.
- Intensify communication with foreign press to expand and enhance BSE relations.
- Create an archive for BSE photography.
- Formation of a committee for each conference, with multiple tasks based on type and size of the conference.

3 Al-Mohandis Journal:

Information Committee was keen to raise the quality level of Al-Mohandis Journal and issue the same on a regular basis. The committee issued the two volumes 56 and 57 during the year 2013. Issue 58 and 59 are under preparation.

4 Almohandis Times:

11 volumes of "Almohandis Times", the electronic newsletter that cover BSE's monthly news, were issued during the year. On the other hand the Information committee has continued, over the past year 2013, to cover the Federation of Arab Engineers and engineering bodies in GCC Countries to BSE news bulletins.



5 Recommendations:

In an endeavor by the Information Committee, to develop Social Media centers with BSE, it is hereby recommended to:

- Participate in competitions of global engineering and local social events in order to spread the culture of engineering.
- Invite all newspapers and media personnel in a special event in order to recognize their efforts and support to BSE.
- Organize field visits to all newspapers and concerned journalists in order to strengthen our r ties.
- Enhance BSE social media participation.
- Enhance links with Government and private universities.



1. Conferences and Training courses:

During the year 2013, BSE conducted Conferences, Seminars and Training Workshops and the income raised from these conferences and Training courses were BD 446,485 and 63,854 respectively. The expenditures incurred for these Conferences and Training Workshops were BD 183,901 and BD 66,153 respectively.

The excess income generated for the conferences and loss incurred for the Training Centre during the year 2013 was BD 262,584 for Conferences and loss of BD (2,299) for the Training courses with an accumulated income of BD 260,285 during the fiscal year 2013.

When compared the year 2012 a decrease of 36% has been incurred for the conferences and training on this fiscal year 2013.

2. Membership:

The income received from the membership fees in the year 2013 was BD 29,980 while the income received in year 2012 was BD 35,785/-.

3. Scholarship and Community Expenses

The scholarship fees allocated to the students during the year 2013 were BD 8,616 while the scholarship in year 2012 was BD 7,597, with a slight increase of BD 1,019 when compared to the year 2012.

4. Rental of BSE Auditorium and Hall:

The rental income of BSE auditorium and seminar room has reduced to BD 7,855 in year 2013 while it was to BD 11,030 in year 2012.

5. Assets:

The fixed assets during the year 2013 is BD 1,715,328 where it was BD 555,536 in year 2012. This increase of BD 1,159,792 was primarily due to the revaluation of land from Nasser Real Estate Agency after

10 years, by taking the fair market value of the land which has an appreciated value from BD 511,236 to BD 1,661,552.

We constructed the new boundary wall and Majilis in front of the Auditorium whereas the Shaded car park and gardening on backside of the HQ building is on progress.

The total Current Assets, comprising of the Cash & Bank balances and Accounts Receivables, was BD 2,529,929 in year the 2013 compared to BD 2,609,444 in year the 2012 which amounts to a slight reduction of BD 79,515.

The total assets during the Year 2013 is BD 4,245,257 where as it was BD 3,164,980 in the year 2012.

6. Fixed Deposits:

The total amount saved as fixed deposit at Banks is BD 2,094,356 with an average interest rate of 1.5% basis varying from 1.4% to 1.75% on Fixed and Time Deposits.

7. H.Q. Building:

During the year 2013 the building maintenance expenses is BD 7,486 whereas it was BD 4,515 during the year 2012. The increase in expenses of BD 2,971 was due to the renovation and internal paintings for the HQ for celebrating the BSE 40th Anniversary.

8. Almohandis Journal:

During the Year 2013, we issued the Al Mohandis magazine which amounted to BD 10,050 in addition we are continuing monthly with "Al Mohandis times" newsletter which reflects all the events and activities of the Society each month.

9. Accounts Receivable:

The accounts receivable for the year 2013 was BD 300,953 while it was BD 396,487 in the year 2012. This decrease of BD 95,534 is due to the limited conference held during this fiscal year 2013.

These receivables are mainly from conferences, exhibitions and workshops held during the fourth quarter of year 2013, payment of which is expected to be received during the first quarter of 2014.

10. BSE 40th Anniversary:

BSE conducted its 40th Anniversary celebration in the year 2013. Where VIPs, Dignitaries and honorable members of the Society were honored In recognition of their contributions and continuous support towards the society. The total expenses incurred for the event was BD 86,458.

11. Financial Summary:

The excess of income over expenditure for the year 2013 was BD 41,899 while it was BD 277,285 in year 2012. Moreover, as agreed in the AGM resolution 10% of the net profit has been provided as reserve for the Members recognition.

12. Recommendations:

The Board of Directors recommends to re-appoint the new Auditing Firm M/s Talal Abu Ghazaleh Organization for auditing of BSE accounts for the period from January to December 2014

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2013

1. ORGANISATION AND ACTIVITIES:

Bahrain Society of Engineers ("the Society") is a social establishment registered with Ministry of Social Development in the Kingdom of Bahrain under the registration no. 73000401 dated July 13, 1972

The principal activity of the Society is promoting engineering knowledge on various engineering disciplines.

2. SIGNIFICANT ACCOUNTING POLICIES:

The accompanying Society's financial statements have been prepared in compliance with IFRS as approved by the International Accounting Standards Board (IASB).

The significant accounting policies adopted are as follows:

(a) Accounting Convention

The financial statements are prepared under historical cost convention.

(b) **Depreciation**

The cost of property, plant and equipment is depreciated by equal annual installments over the estimated useful lives except for freehold land which is not depreciated. The estimated useful lives are as follows:

Building 20 years
Boundary wall 10 years
Central air-conditioning unit 10 years
Furniture and fixtures 8 years
Office equipment 4 years

Freehold land is revalued every year, based on market value appraisal made by independent property valuers. When an asset is revalued, any increase in the carrying amount arising on revaluation is accumulated in "Funds and Reserve" under the heading "revaluation surplus" unless it represents the reversal of a revaluation decrease of the same asset previously recognized as an expense, in which case it is recognized as income. A decrease arising as a result of a revaluation is recognized as an expense to the extent that it exceeds any amount previously credited to revaluation surplus relating to the same asset. When a revalued asset is disposed of, any revaluation surplus is transferred directly to general funds.



NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2013

2. **SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):**

(c) Accounts Receivable

Accounts receivable are carried at their anticipated realizable values. An estimate is made for doubtful receivables based on a review of all outstanding amounts at the year end.

(d) Accounts Payable

Accounts payable are recognized for amounts to be paid in the future for goods or services received, whether billed by the supplier or not.

(e) Employees' Terminal Benefits

Provision is made for amounts payable under the Bahrain Labour Law applicable to employees' accumulated periods of service and their entitlement to salaries at the reporting date.

(f) Revenue recognition

Members' subscription income is accounted for on accrual basis. Income from conferences and seminars, workshops and training courses are recognized in the year of receipt.

Interest income, rental income and other income is recognized on the accruals basis, unless collectability is in doubt.

(g) Foreign Currencies

Foreign currency transactions are recorded in Bahraini Dinars at the approximate rates of exchange prevailing at the time of the transactions. Assets and liabilities denominated in foreign currency at the reporting date are translated at the year end rates of exchange. Exchange differences, not considered material, are reported as part of the results for the year.

(h) Cash and Cash Equivalents

Cash and cash equivalents consist of bank balances and cash on hand including short term bank deposit having original maturities of three months or less.

8. **FINANCIAL ASSETS AND LIABILITIES:**

Financial assets and liabilities carried on the statement of financial position include cash and cash equivalents, accounts and other receivables and accounts and other payables. The particular recognition methods adopted are disclosed in the individual policy statements for each item.

Currency risk is the risk that the value of a financial instrument will fluctuate due to change in foreign exchange rate. The Society has not hedged its currency exposure. However, management is of the opinion that the Society's current exposure to currency risk is minimal as majority of the foreign currency financial assets and liabilities are denominated in currencies that have a fixed exchange rate with its functional currency.

Credit risk is the risk that one party will fail to discharge an obligation and cause the other party to incur a financial loss. Cash is placed with a national bank with a good credit rating. Credit risk on accounts receivable is limited to membership and conference income which are carried net of provision for impaired accounts receivable.

8. **FINANCIAL ASSETS AND LIABILITIES (CONTINUED):**

Interest rate risk is the risk that the value of a financial instrument will fluctuate due to the changes in the market interest rates. The Society's short-term bank deposits bear fixed rates of interest and are renewable on maturity. The Society's other assets and liabilities are not subject to interest rate risk.

Liquidity risk is the risk that an enterprise will encounter difficulty in raising funds to meet commitments associated with financial assets and liabilities. Liquidity risk may result from an inability to sell a financial asset quickly at close to its fair value.

Liquidity risk is managed by monitoring on a regular basis that sufficient funds are available with banks to meet future commitments as they fall due.

Fair value is the amount, for which an asset could be exchanged, or a liability settled between knowledgeable, willing parties in an arm's length transaction.

The fair values of financial assets and liabilities of the Society are not materially different from their carrying amounts.
